Total number of shares and voting rights at the time of the convening the AGM and EGM

As of 15 May 2026, date of the convening of the AGM and EGM, the Company’s subscribed share capital equals one hundred and eleven million forty-seven thousand five hundred and ninety-five euro and fourteen cents (EUR 111,047,595.14) and is divided into thirty-nine million nine hundred ninety-nine thousand nine hundred ninety-eight (39,999,998) shares without nominal value, all of which are fully paid up.

Each share entitles its holder to one vote, so that the total number of possible votes at the time of convening the AGM and EGM is 39,999,998.
